Thank you for visiting Opalapay.com. This privacy policy applies to Opalapay.com owned and operated by Opala Payment Systems. This privacy policy describes how Opala Payment Systems collects and uses the personal information you provide on our web site: www.Opalapay.com. It also describes the choices available to you regarding our use of your personal information and how you can access and update this information. Opala Payment Systems (“We”, “Us”, “Our”) is committed to safeguarding the privacy and security of the information we collect. Any information you provide on the web site will only be used and to provide or improve the services we offer. We do not disclose any nonpublic personal information about our customers or former customers to any nonaffiliated third parties.

Collection of Information

When visiting websites, visitors provide information to the site owners based on where they go and what they do at each sites. From time to time, we may ask our site visitors to answer survey questions. Surveys generally deal with the site, our products or categories of products and they will not request any personally identifiable data.
